and beneficiaries).

Use: To gather information for administrative reviews and appeals for the board

regarding the issue in dispute; to respond to appeals of administrative decisions provided by the pension plan administrator; to complete appeal hearings; to obtain legal advice for determination of benefits entitlement;

and to respond to complaints and legal discovery requests.

Legal Authority: Public Sector Pension Plans Act, Access to Motor Vehicle Information

Regulation, Legislative Provisions Regulations, Federal Income Tax Act,

and the Freedom of Information and Protection of Privacy Act
